TRAINER'S GUIDE

Trainers guide: is an outcome of a year long series of workshops involving expertise from all over the country including FPO directors and their staff.

The guide is designed to offers modules which cover the key areas that an FPO director requires knowledge and skills:

- Basic concepts of an FPO.
- Statutory requirements,
- Marketing and Networking,
- FPO management and
- Business Planning.

PACKAGE OF SERVICES

- 6 month period of modular training 5 sets of 3 day capsules combined with field based assignments
- Followed by minimum 1 year mentoring
- Needs assessment allows for tailor made capacity building
- All trainings in local language by experienced facilitators and co-facilitators
- Aimed primarily for FPO directors though CEOs can attend and support the directors later.

EXPECTED OUTCOMES

- National pool of trainers available at regional levels
- FPO directors will undergo modular capacity building based on their needs
- National pool of mentors for ongoing support to FPO directors
- Shared experiences documented for learning and dissemination
